Dr. Brown received his medical degree from Howard University School of Medicine in Washington, DC, and completed a residency at Louisiana State University, Charity Hospital. He received a Master of Business Administration degree from the University of Louisiana at Lafayette. Dr. Brown maintained a solo private practice in Lafayette, Louisiana, for 28 years and served as Medical Director, Vice President for Medical Affairs, and Chief Medical Officer of Woman's Hospital in Baton Rouge, LA. He is an Associate Clinical Professor in Obstetrics-Gynecology at LSU Health Science Center Residency Programs and served as Department Head and Chief of Obstetrics-Gynecology at University Medical Center in Lafayette. He received his undergraduate degree from Dillard University in New Orleans, LA.

Dr. Brown presently consults on matters of Healthcare and Quality Improvement. He is Senior Executive Vice President for Risk Management and Patient Safety for Louisiana Medical Mutual Insurance Company (LAMMICO).

Following a solo private practice, he entered hospital administration at Our Lady of Lourdes Regional Medical Center and served as Medical Director, Vice President of Medical Affairs, Vice President of Patient Care Services, and Senior Vice President/Chief Medical Officer.

Dr. Brown is a Diplomate and Fellow of the American Board of Obstetrics and Gynecology.
